## Generic Event Parking / Park & Ride - Terms & Conditions

## PLEASE NOTE YOU ARE PURCHASING A TICKET TO ONE OF THE OFFICIAL EVENT CAR PARKS – YOU ARE NOT PURCHASING A TICKET TO THE EVENT.

## EVENT CAR PARKS ARE OPERATED BY THE CITY & COUNTY OF SWANSEA

- 1. The City & County of Swansea reserves the right to refuse admission to the holder if, in the reasonable opinion of the promoter, the holder of the ticket might be a risk to the safety of the audience and / or the holder and / or affect the enjoyment of the audience and / or the running of the event.
- 2. The City & County of Swansea does not accept responsibility for any loss, injury or damage to the holder or the holder's property.
- 3. If the event is cancelled, the holder as the holder's sole remedy may ask that the City & County of Swansea refunds the face value of the parking ticket. This multiple stage event is judged by reference to the overall theme rather than the individual artists scheduled to appear. Therefore if for unavoidable circumstances a scheduled artist is unable to perform but the event continues to run, no refunds will be issued. Booking fees and postage costs are non-refundable in all circumstances.
- 4. For the avoidance of doubt, if a Ticket holder chooses not to use a ticket for any reason, no refund will be given.
- 5. There are no vehicle re-admissions once leaving the car park.
- 6. Car parks maybe located on greenfield sites and the ground may be uneven. There may be temporary roadways and ramps. Please take care when walking on and off the roads and ramps or crossing them in wheelchairs or children's buggies.
- 7. In the interest of fraud protection, no tickets will be replaced or ticket prices refunded if a ticket is forgotten, lost, stolen, defaced, damaged or otherwise unavailable.
- 8. There may be an administration charge/booking fee for the issue of the tickets; this may be variable with each individual Box Office.
- 9. No tickets may be resold, used for competitions, promotions or hospitality packages without the written consent of the City & County of Swansea. Any tickets re-sold or transferred in such a manner will become voidable and the holder may be refused entry.
- 10. In the interests of safety, please do not bring glass items, barbecues, candles or flaming torches.
- 11. In the event of any breach of any of these conditions by the holder, the City & County of Swansea reserves the right to cancel this ticket and retain any money paid for it
- 12. Ticket holders must comply with all directions given by event personnel and stewards whilst at the event.
- 13. Ticket holders consent to being filmed, photographed and recorded and understand that photographs, films or recordings of ticket holders may be broadcast, published, licensed or used in perpetuity (without payment).
- 14. Ticket holders agree that any personal images, videos, or sound recordings taken at the event may only be used for private and domestic purposes and cannot be used for any commercial purposes, whether on the internet or otherwise.
- 15. The City & County of Swansea shall have the right to copy, make available and use any images, videos or audio recordings that Ticket holders create as seen fit, without having to make any payment or acknowledgment that the Ticket holder created that material.

- 17. Event attendees release the City & County of Swansea from any liability for any loss or damage to personal property that may be suffered in relation to the event. Except as required by law.
- 18. Tickets may not be resold (including by way of auction) nor advertised for sale. Tickets may not be used for advertising, promotion, fundraising or marketing purposes (including in competitions, contests and sweepstakes).
